2. Amendment of the Statutes and Regulations

Resolutions

2.1. Statutes

According to Article XI of the Statutes, the Executive Committee moves that the forthcoming General Assembly should adopt the following recommendations:

1. The title "First Vice-President" shall become:

Executive President.

- 2. The following titles shall be retained unchanged:
 - President Secretary General Reporter General Treasurer General Assistant Secretary General Assistant Reporter General Assistant Treasurer General.

3. The following office shall be introduced:

Executive Vice-President.

The Executive Vice-President is the President of the National or Regional Group hosting the next Congress but one.

4. The Bureau shall be composed of the following officers:

- 1. Executive President
- 2. Executive Vice-President
- 3. Secretary General
- 4. Reporter General
- 5. Treasurer General
- 6. Assistant Secretary General
- 7. Assistant Reporter General
- 8. Assistant Treasurer General.

The Executive Vice-President has no voting right in the Bureau.

5. If the Executive President is prevented from attending any meeting of the BUREAU, the Executive Vice-President shall deputize for him. In this case, the Executive Vice-President shall have a right to vote.

6. The President shall have the right to take part, but not vote, at all the meetings of the Bureau. He shall be invited to all meetings of the BUREAU and shall be kept informed about all important matters.

7. The post of an "Editor" shall be introduced.

The Editor shall be elected by the Executive Committee, and his term of office shall be of 3 years (corresponding to the term of office of the members of the BUREAU).

There shall be provisions in the Statutes for carrying out an audit and for release of all the organs concerned.

2.2. Regulations

As regards the Regulations, the Executive Committee has decided that they should be amplified as follows:

1. The rights and duties as well as the responsibility of the Editor with respect to third parties shall be clearly stated.

2. The auditing of the accounts shall be carried out either by auditors elected from among the members of the Executive Committee and/or by professional accountants or sworn chartered accountants. The audit report shall be presented to the Executive Committee.

The Regulations shall contain necessary provisions concerning the release of all organs concerned.

3. The Regulations shall provide for "junior membership". Junior members shall be members who have not yet reached the age of 30. While fixing the international membership fees, the Executive Committee shall also fix the reduced amount which shall be paid to the Association by junior members.

Question 50 - Reorganisation of the IAPIP

The IAPIP

approves the recommendations of its Committee 50 on the amendment of the Statutes and

invites its General Assembly, according to Article XI of the Statutes, to adopt these amendments.
